By this letter we inform you about the Material-Compliance of our delivered industrial valves:

- **REACH**

In accordance with Article 33 of the Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH), we inform you that some of our products we supply to your company contain a substance from the REACH candidate list.

The following substances are indicated in our industrial valves:

Note Lead: The substitution of lead is not feasible in many metal alloys currently. Lead appears as chip breaker and lubricant, improves the machinability of metal alloys and gives the finished part further properties like e.g. corrosion resistance. In addition, lead increases other characteristics like the sliding and dry-running performance.

Note Chromium Trioxide: Applications for further transitional arrangements have been made by the manufacturers of Chromium Trioxide products. A final decision to the future use of Chromium Trioxide has not been made yet by the EU Council.

The data transfer to ECHA as an entry in the so-called "SCIP database" was carried out in due time before 05.01.2021. For questions regarding our SCIP dossiers, please contact us.
